## **Coming Soon: Naloxone Training**

The Ontario government is launching a first-of-its-kind program to make free naloxone kits (and free training) available at workplaces where there is a risk of staff witnessing or experiencing an opioid overdose. In 2021, 2,819 people died from opioid-related causes in Ontario – the highest number on record and up from 366 in 2003. Naloxone is a life-saving medication that can temporarily reverse an opioid overdose, restore breathing within two to five minutes, and allow time for medical help to arrive. Of the workers who died from opioid-related causes last year, 30% were employed in construction – by far the most impacted industry. Bars and nightclubs have also seen increased opioid usage and accidental overdoses, often because of recreational drugs laced with deadly opioids.

Dunk & Associates will be creating Naloxone training compliant with the Occupational Health and Safety Act for our Ontario employers who require it. #### **Coming Soon: Naloxone Training**

Starting June 1, 2023, employers must provide naloxone in the workplace if there is a risk of a worker overdosing in the workplace as prescribed by the Occupational Health and Safety Act.

Not all employers have to comply with the OHSA requirements to provide naloxone in the workplace. Employers must provide a naloxone kit when an employer becomes aware, or ought reasonably to be aware, of the following scenarios:

- There is a risk of a worker opioid overdose.
- There is a risk that the worker overdoses while in a workplace where they perform work for the employer.
- The risk is posed by a worker who performs work for the employer.

For a limited time, those employers can get free naloxone training and nasal spray naloxone kits through Ontario's Workplace Naloxone Program.

Dunk & Associates is currently creating Naloxone training compliant with the Occupational Health and Safety Act for our Ontario employers who require it. The training includes how to recognize an opioid overdose, instructions on how to administer naloxone, and a review of hazards related to the administration of naloxone.

#### **Ontario JHSC Certification**

Have you had turnover or changes in your committee? When was the last time you checked that you have the required number of certified members? Dunk & Associates is approved by the Chief Prevention Office to offer both Part 1 and Part 2 JHSC Certification training in Ontario. Under Ontario's Occupational Health and Safety Act, companies in Ontario with 20 or more employees are required to have a Joint Health and Safety Committee (JHSC) that complies with the Act. For most, that means having at least 2 committee members - 1 worker and 1 management representative - certified in health and safety. We do, however, encourage all members to be certified. JHSC certification training can also be used for training health and safety representatives.

- Time Off/Shift Change Request Cancelled: This email is sent to selected administrators when a user has cancelled a time off request through the Employee Scheduler program.
- Time Off/Shift Change Request Approved: This email is sent when an administrator has approved a time off request through the Employee Scheduler program.
- Time Off/Shift Change Request Denied: This email is sent when an administrator has declined a time off request through the Employee Scheduler program.

### **WHMIS Update**

WHMIS 2015 has now been legislatively changed from WHMIS 2015 back to WHMIS. For most workplaces, the most notable change is the adoption of a new physical hazard class, chemicals under pressure, the adoption of a non-flammable aerosols hazard category, and new subcategories for flammable gases. There are also some updates to information required on SDSs and labels including modifications concerning the physical and chemical properties in section 9 of the SDS.

There is a 3-year transition period where Employers and Suppliers have until December 14th, 2025, to update their SDSs, labels, and training to bring them into compliance. As of October 1st, 2023, Dunk & Associates/Systems 24-7 has revised the WHMIS 2015 module to be called WHMIS and all necessary updates have been made. Employees are not required to re-take the module (unless the Employer chooses to). Instead, attached is a Safety Talk called WHMIS Update which can be been delivered and signed off on by all employees. All new hires must still complete their WHMIS training as required. If you are a Full Service Health & Safety client with Dunk & Associates, this safety talk has already been posted on your website as part of the October Compliance Package.
